

CANDIDATE REQUEST TO USE CANDIDATE'S MIDDLE NAME OR DERIVATIVE OF MIDDLE NAME ON THE BALLOT AND SUPPORTING AFFIDAVITS

Except as otherwise provided in Utah Code § 20A-6-109, pursuant to Utah Code § 20A-6-109(1), a candidate's name on the ballot shall be the candidate's legal first name followed by the candidate's legal surname. An election offer shall place a candidate's legal middle name or a common derivative of the candidate's legal middle name on the ballot in place of the candidate's legal first name if the candidate submits a request, an affidavit, and supporting affidavits as specified in Utah Code § 20A-6-109(2).
